**MARYLAND ENERGY ADMINISTRATION
 OPENS INNOVATIVE WOOD STOVE GRANT
 PILOT PROGRAM: \$50,000 in Grants
 Available for Residential Clean Wood and
 Pellet Stoves**

On September 7, 2012, the Maryland Energy Administration (MEA) began accepting grant applications for clean burning wood stove installations that displace electric or non-natural gas fossil fuel heating systems as part of its Residential Clean Energy Grant Program. This is the first in a series of activities that MEA plans to implement to help develop the bioenergy market in Maryland. "This program allows clean and renewable energy to be brought right into the homes of Marylanders, while advancing the endeavors of our growing bioenergy sector," said Fred Hoover, MEA's Director of Clean Energy.

\$50,000 will be available to Maryland home owners who purchase and install approved stick (log) or pellet wood stoves on a first-come, first-served basis. For each individual stove purchased and installed, \$400 will be available for stick wood stoves that are Environmental Protection Agency certified and emit no more than 3 grams of PM/hr., and \$600 for pellet wood stoves that meet Washington Emission Standards and emit no more than 2 grams of PM/hr.

This initiative has been championed by Delegate Heather Mizeur (D- Montgomery County), who praised MEA's efforts to implement this cost saving program. "Modern wood and pellet stoves offer rural families a way to take charge of their clean energy future," said Del. Mizeur. "Thanks to MEA for establishing this valuable grant program."

Recipient of the 2012 Master Logger Award

The MD/DE Master Logger Steering Committee is pleased to announce Brian Blickenstaff as the 2012 Logger of the Year.



Brian runs a **one-man logging operation that has maintained its place in today's tough market by specializing** in small and difficult jobs, and by focusing on excellent customer service and public relations. Brian regularly cuts parcels of less than ten acres, and sometimes works on parcels as small as one half acre. He is skilled in harvesting hazard and property line trees, and is sometimes called in to clean up a job site and harvest the timber left behind by larger logging operations. Most of his jobs are select harvest.

Brian generally runs the skidder and loader, and contracts Coblens Forest Products to do the cutting. Brian has a Wolverine three-wheeled rotary saw tree cutter, but most of the cutting is manual. Other equipment in his mix includes a Peerless 2770 loader with delimeter, a Cat 525 skidder, a slasher saw, and an ATV for seeding. All trucking is also contracted out. Brian does all of his own minor maintenance, and has recently begun sending his oil to a lab for analysis.

Brian cares deeply about aesthetics and makes sure that the landowner is happy with the way a job looks before leaving a site. He designates certain trees as bumper trees for skidding, and removes them and any other damaged trees. **Tops and slash are piled or cut down to six feet high according to the landowner's preference.** Brian is happy to leave a pile of slash in an easily accessible place for firewood. He protects specimen or crop trees by carefully placing large rocks at their base, as guards against logs and equipment. **In his words, "Trying to make each individual happy is the goal" of every logging job.**

Brian is an expert in utilization and marketing, and usually keeps four piles on the landing: firewood, pulpwood, low grade logs, and high grade logs.

Brian has harvested timber in the Frederick City Watershed forest, an area used heavily by the public. The DNR foresters were impressed with his diligence and the cleanliness of his work, and received calls from the public to compliment the job. According to Larry Maxim, a forester with the Maryland Forest Service, **it was "very refreshing to know that it would be a good job. He did it all to near perfection."**

Brian has an excellent reputation with his clients and the foresters he works with, and has managed to maintain a niche for himself as a service provider for small landowners and for difficult harvest jobs in market conditions that have weeded out many similar operations.


